- #1 **ULTRA LOW SULFUR NON-HIGHWAY DIESEL FUEL (15PPM SULFUR MAXIMUM)**
Warning! Federal Law prohibits use in highway vehicles or engines.
Required for use in all model year 2011 and newer non-road diesel engines - Recommended for use in all non-road, locomotive & marine diesel engines.
From 6/1/07 through 5/31/2010 For pumps dispensing NRLM diesel fuel meeting the 15-ppm sulfur standard.
- #2 **LOW SULFUR NON-HIGHWAY DIESEL FUEL (500PPM SULFUR MAXIMUM)**
Warning! Federal Law Prohibits use in highway vehicles or engines
From 6/1/07 through 5/31/2010 for pumps dispensing NRLM diesel fuel meeting the 500-ppm sulfur standard
- #3 **HIGH SULFUR NON-HIGHWAY DIESEL FUEL (MAY EXCEED 500PPM SULFUR)**
Warning! Federal Law prohibits use in highway vehicles or engines. May damage non-road diesel engines required to use low-sulfur or ultra-low sulfur diesel fuel. From 6/1/07 through 9/30/2010 for pumps dispensing NRLM diesel fuel not meeting or not offered as meeting the 500ppm sulfur of the 15ppm sulfur standard.
- #4 **HEATING OIL (MAY EXCEED 500PPM SULFUR)**
Warning! Federal law prohibits use in highway vehicles or engines, or in non-road, locomotive or marine diesel engines. Its use may damage these diesel engines. From 6/1/07 and beyond, for pumps dispensing non-motor vehicle diesel fuel for use other than in non-road, locomotive or marine engines, such as for use in stationary diesel engines or as heating oil.
